ORDINANCE NO. 16-02

AN ORDINANCE REPEALING CHAPTER 54 SEWER REGULATIONS AND
APPROVING A NEW CHAPTER 54 SEWER REGULATIONS FOR THE
KOCHVILLE TOWNSHIP CODE OF ORDINANCES

WHEREAS, the Township codified its ordinances into a document commonly known as the Kochville Township Code of Ordinances (“Codification”); and

WHEREAS, Chapter 54 of the Codification regulates sewers; and

WHEREAS, the Township and its Public Works believe the current Chapter 54 of the Codification is outdated and the entire Chapter requires updating; and

WHEREAS, the Township directed a law firm to assist the Township Manager and Township Public Works director in preparing a new Chapter 54 to the Codification to regulate sewers (attached hereto and incorporated herein by reference) (“New Chapter 54”); and

WHEREAS, the Township was presented with a draft of the New Chapter 54 to regulate sewers; and

WHEREAS, the Township scheduled a public hearing on the proposed New Chapter 54 on February 15, 2016; and

WHEREAS, after considering all of the comments and statements regarding the New Chapter 54 during the public hearing on February 15, 2016, the Kochville Township Board desires to repeal the existing Chapter 54 of the Codification and replace it with the New Chapter 54.

KOCHVILLE TOWNSHIP HEREBY ORDAINS:

The foregoing was offered by board member Clerk Machata and seconded by board member Supervisor Loiacano:

- (1) That current Chapter 54 of the Township of Kochville Code is hereby repealed in its entirety.
