**A RESOLUTION TO ADD A FEE TO THE
PERMIT FEE SCHEDULE FOR TEMPORARY USE PERMITS**

WHEREAS, Kochville Township, Saginaw County, Michigan (“Township”) desires to add a fee that pertains to Temporary Use Permits issued for the placement and number of storage containers located on parcels within the township.

WHEREAS, the proposed fee is necessary to cover township costs in association with the enforcement of the “zoning ordinance” and inspection required for such permits; and that the Kochville Township Board of Trustees may adjust any fees, add to, and/or delete from the Schedule of Fees and Charges which is subject to change annually or at the discretion of the Township Board; and

WHEREAS, on June 17th, 2019, the Kochville Township Board of Trustees received and reviewed the proposed revision to and addition to the Schedule of Fees and Charges; and

WHEREAS, a fee schedule for the Temporary Use Permit application has been developed as provided and here attached;

NOW THEREFORE BE IT RESOLVED THAT, that the Township Board hereby adopts by resolution the fee for the described permit as attached hereto, and that any other fees not so mentioned remain intact in the Schedule of Fees and Charges until further changed by the Board. The Schedule of Fees is revised and is effective upon the signing of this resolution.
