Saginaw County, Michigan  
Resolution No. 20-23**

**A RESOLUTION TO ADOPT WATER AND SEWER RATES AND CHARGES REPEALING RESOLUTION No. 20-09 AND ALL RESOLUTIONS OF KOCHVILLE TOWNSHIP THAT ARE IN CONFLICT THERWITH.**

**WHEREAS**, the Board of Trustees would like to amend connection and usage charges to customers of Kochville Township water and sewer systems;

**THEREFORE, BE IT RESOLVED**, that the Township Board hereby establishes the following water and sewer rates and changes:

1. Water rates will be **\$6.13** per metered thousand (1,000) gallons effective August 1, 2020 billing. In addition, a quarterly Readiness to Serve (RTS) charge will be applied as follows:

2. Sewer rates will be **\$5.43** per metered thousand (1,000) gallons effective with the August 1, 2020 billing. In addition, a quarterly Readiness to Serve (RTS) charge will be applied as follows:

3. An indirect charge will be 60 percent of the direct Capital Fee. Indirect Capital fees will be applied when the property owner provides substantial improvements to the water or sewer system, which become part of the water or sewer system.
4. Future rate increases from the City of Saginaw will be automatically applied on the next Township billing cycle.
5. Sewer only customers not receiving municipal water will be charged as listed in the Sewer Rate table.
6. New connections, not located on property in an existing Special Assessment District, will be charged a Capital Fee in accordance with the number of Residential Equivalent Units (REU) as determined by the Kochville Table of Unit Factors. The Kochville Table of Unit Factors is hereby adopted by reference, as amended from time to time by the Township Board. The Capital Fee for 2019 shall be **\$2,970** per REU for water and **\$3,502** per REU for sewer.
7. Any change in use will be evaluated by the Township and additional REUs may be assigned and additional Capital Fees collected. There will be no refund for a reduction in use, however the REUs associated with the use remain with the property.
8. All new connections in an active Special Assessment District that were not part of the original assessment roll shall be charged the same amount as the original members of the Special Assessment District.
9. Tap-in fee ¾" – The cost to physically bring water line from the public water main to the property line or easement line, assuming water is available in front on the property, including ¾ inch meter, and valve inspection fee: \$2,300.00
10. Tap-in fee 1"- The cost to physically bring water line from the public water main to the property line or easement line, assuming water is available in front on the property, including 1" inch meter, and valve inspection fee: \$2,500.00
11. Meter Cost - ¾ ", including related supplies and inspection fee: \$400.00.
12. Meter Cost - 1", including related supplies and inspection fee: \$475.00.
13. Meter Cost – larger than 1" costs to be determined by the Township as needed.
14. Demolition – Water and sewer service lines to a structure that is being demolished or moved from the site will be charged at a time and material rate to disconnect and/or cap the water line at the main and the sewer line at the right of way to the satisfaction of the Department of Public Works. The cost of said disconnects will be billed to the property owner of record.
15. Water shut off charge shall be \$100.00
