

ORDINANCE NO. 20-02

TOWNSHIP OF KOCHVILLE

SAGINAW COUNTY, MICHIGAN

AN ORDINANCE RECODIFYING KOCHVILLE TOWNSHIP'S CODE OF ORDINANCES AND ADOPTING A SUPPLEMENT THERETO

An ordinance of Kochville Township to provide a title for the ordinance; to adopt a recodification of the Code of Ordinances, Township of Kochville, Michigan, as authorized and provided for in MCL 41.186, including amendments, repeals, revisions, and rearrangements of ordinances or parts of ordinances in the Kochville Township Code; to adopt a supplement to said code of ordinances; to provide for severability; to repeal all ordinances or parts of ordinances in conflict herewith; and to provide an effective date.

WHEREAS, Kochville Township has engaged American Legal Publishing Corporation of Cincinnati, Ohio, to complete a supplement to the Code of Ordinances of Kochville Township which supplement contains all ordinances of a general and permanent nature enacted since the prior supplement(s) to the Code of Ordinances of Kochville Township.

WHEREAS, it is necessary to provide for the usual daily operation of Kochville Township and for the immediate preservation of the public peace, health, safety and general welfare of Kochville Township and the residents thereof that this ordinance take effect.

Accordingly, the Board of Trustees of Kochville Township ordains as follows:

SECTION I: TITLE

This ordinance shall be known as and may be cited as the Kochville Township Re-Codification of Code of Ordinances Ordinance.

SECTION II: RE-CODIFICATION OF ORDINANCES

The Kochville Township Code is hereby recodified to include all previously-adopted Ordinances (including all Chapters, Provisions, Articles, Divisions, and Appendices thereof). The previous codification of any and all Kochville Township Ordinances is hereby ratified and approved.

SECTION III: CODIFICATION SUPPLEMENT

The supplement to the Code of Ordinances of Kochville Township as submitted by American Legal Publishing Corporation of Cincinnati, Ohio, is hereby adopted by reference as if set out in its entirety. Such Supplement shall hereby be deemed published as of the day of its adoption and approval by the Township Board and the Kochville Township Clerk is hereby authorized to insert such supplement into the copy of the Code of Ordinances kept on file in the Office of the Clerk.

SECTION IV: SEVERABILITY

The provisions of this ordinance are hereby declared to be severable. If any clause, sentence, word, section or provision is hereafter declared void or unenforceable for any reason by a court of competent jurisdiction, it shall not affect the remainder of such ordinance which shall continue in full force and effect.

SECTION V: REPEAL

All ordinance or parts of ordinances in conflict herewith are hereby repealed.

SECTION VI: SAVINGS CLAUSE

All proceedings pending and all rights and liability existing, acquired or incurred at the time the Ordinance takes effect are saved and may be consummated according to the law in force when they were commenced, nor shall any just or legal right or remedy of any character be lost, impaired or affected by this Ordinance.

SECTION VII: INSPECTION OF ORDINANCE

SECTION VIII: TOWNSHIP PUBLICATION

The Township Clerk is hereby ordered and directed to cause this Ordinance, or a summary thereof, to be published in a newspaper of general circulation within Kochville Township as required by Michigan law.

SECTION IX: EFFECTIVE DATE

This Ordinance, as amended, shall take effect 1 day after publication as required by law following adoption by the Township Board.

This Ordinance is hereby declared to have been adopted by Kochville Township Board, County of Saginaw, State of Michigan, at a regular meeting held on the twentieth day of July, 2020 and ordered to be given publication in the manner prescribed by law.

Summary of Ordinance No. 20-02, an Ordinance Re-Codifying Kochville Township's Code of Ordinances and Adopting a Supplement Thereto. Ordinance No. 20-02 was adopted by Kochville Township Board of Trustees at its regular meeting on July 20, 2020.

Section 1: Title. This Section prescribes a title for this Ordinance, namely: the Kochville Township Re-Codification of Code of Ordinances Ordinance.

Section 2: Re-Codification of Ordinances. This Section serves to ratify, re-approve, and re-codify all previously-adopted Kochville Township Ordinances (including all Chapters, Provisions, Articles, Divisions, and Appendices thereof).

Section 3: Codification Supplement. This Section adopts a supplement to the Kochville Township Code of Ordinances.

Section 4: Severability. This Section states that if any part of the Ordinance is found to be invalid, the remainder of the Ordinance will remain in effect.

Section 5: Repeal. This Section states that any Kochville Township ordinances or part(s) thereof in conflict with this Ordinance are repealed.

Section 6: Savings Clause. This Section prescribes that this Ordinance will not abridge any proceeding, right or liability existing at the time of the adoption of this Ordinance.

Section 7: Inspection of Ordinance. This Section states that a copy of Ordinance No. 20-02 may be inspected and obtained at 5851 Mackinaw Road, Saginaw, Michigan from the Clerk of Kochville Township.

Section 8: Publication. This Section states that the Ordinance is ordered to be published as required by law.

Section 9: Effective Date. This Section states that the Ordinance is effective the day following its publication in a paper of general circulation in Kochville Township.
