ORDINANCE NO. 18-01

**AN ORDINANCE AMENDING KOCHVILLE TOWNSHIP ORDINANCE 17-08
(KOCHVILLE TOWNSHIP SIDEWALK ORDINANCE)**

Enabling Ordinance 17-08

Purpose:

To amend Ordinance 17-08, that provides for the construction standards to which new sidewalks and replacements sections of sidewalks shall meeting during installation to ensure the longevity of the sidewalks; the payment of the sidewalks; the determination of the need to repair hazardous conditions and notice and methods of service to property owners.

KOCHVILLE TOWNSHIP ORDAINS:

Ordinance No. 17-08 is hereby amended as follows:

SECTION 1. Amendment.

SECTION THREE. CONSTRUCTION SPECIFICATIONS AND STANDARDS, subsection (f) of Ordinance 17-08 shall be and the same is amended to read as follows:

Section Three (f) of Ordinance No. 17-08 is hereby amended to read as follows:

(f) Under Public Act No. 246 of 1931, as amended (MCL §41.288 *et. Seq.*), the township board may construct, repair or maintain, or may order the construction, repair or maintenance of, sidewalks for the health, safety and general welfare of the residents of the township after notifying the involved property owners of the time and place of a hearing on such order. Following the hearing, the Township may construct, repair or maintain the sidewalk and bill the property for the construction, repair or maintenance in the following manner:

(1) If the cost of construction, repair, or maintenance is \$999.99 or less, the Township shall invoice the property owner and the amount due and owing to the Township shall be paid within thirty (30) days of receipt.

(2) If the cost of construction, repair or maintenance is \$1000.00 or greater, the Township may assess the cost over a five (5) year period against the abutting property owners, which assessment shall be collected and treated in the same manner as taxes assessed under the general laws of the state or permit the owners within a specified time to have the sidewalk constructed, repaired or maintained according to the specifications of this ordinance at their expense.

(3) The Township Board, at its discretion, may also, after constructing, repairing or maintaining a sidewalk, authorize collection of the costs of such construction, repair or maintenance by civil process, counterclaim, or such other means as may be proper for the collection of debts by legal process.

SECTION 2. Repeal.

All Ordinances or parts of Ordinances of Kochville Township inconsistent or in conflict with this Ordinance are repealed.

SECTION 3. Invalidity.

If any section, paragraph, sentence, clause, phrase or part of this Ordinance shall be declared invalid for any reason whatsoever, such a decision shall not affect the remaining portions of this Ordinance which shall remain in full force and effect and to this end the provisions of this Ordinance are hereby declared severable.

SECTION 4. Effective Date.

This Ordinance will become effective immediately upon its adoption and publication as required by law in a paper of general circulation in Kochville Township.

SECTION 5. Where Ordinance Can Be Inspected.

A copy of this Ordinance can be obtained from the Clerk of Kochville Township at the offices of the Kochville Township, 5851 Mackinaw Road, Saginaw, Michigan.

SECTION 6. Publication.

This Ordinance is ordered to be given publication as required by law.


