DEPARTMENT TO APPLY FOR MICHIGAN TOWNSHIP PARTICIPATING PLAN
RISK REDUCTION GRANT**

WHEREAS, the Kochville Township Fire Department seeks approval from The Kochville Township Board of Trustees to submit an application for the Michigan Township Participating Plan Risk Reduction Grant

WHEREAS, the Michigan Township Participating Plan requires that this Township Board adopt a Resolution in connection with the approval of said grant and that the resolution of approval be submitted with the grant application.

WHEREAS, the grant would be used to install back up cameras on Kochville Township Fire Department Apparatus consisting of Engine 7, Engine 11, Rescue 8, Tender 9, and Brush 10.

WHEREAS, the grant requires a 50% match by Kochville Township.

WHEREAS, the project would be awarded to Redmond's Automotive and Kochville Township Fire Department would be responsible for \$1,221.00.

NOW, THEREFORE, BE IT RESOLVED, the Kochville Township Board of Trustees approves The Kochville Township Fire Department to submit an application for the Michigan Township Participating Plan Risk Reduction Grant for back up cameras for the fire department apparatus listed above, with Kochville Township matching the amount of \$1,221.00 and the project being awarded to Redmond's Automotive.




