**A RESOLUTION TO APPROVE KOCHVILLE TOWNSHIP'S CONTINUING EFFORTS TO SECURE FINANCING, THROUGH BOND FINANCING AND GRANTS WHICH ARE AVAILABLE THROUGH USDA OFFICE OF RURAL DEVELOPMENT**

**WHEREAS**, Kochville Township has previously been notified by the City of Saginaw of its intention to relocate its treated municipal water main which is located in the Davis Road right of way; and

**WHERE AS**, residents of Kochville Township are currently receiving municipal water service from the City of Saginaw and depend upon the continued water service; and

**WHERE AS**, this Township Board established a special assessment district for the purpose of constructing a replacement water main for the benefit its Davis Road residents on May 15, 2017 and has also pursued financing options for the water main replacement; and

**WHERE AS**, the USDA office of Rural Development has expressed an interest in providing funding for the water main, including the possibility of partial grant funding, and has received the Township's application for financing the Davis Road water main project beginning at the intersection with Kochville Road and continuing to a point south of Pierce Road; and

**WHERE AS** this Township on May 4, 2017 published its notice of intent to file application for loan and grant with USDA Rural Development.

**THEREFORE, BE IT RESOLVED:** This Township Board supports the Township's continuing efforts to secure financing, through bond financing and grants which are available through USDA office of Rural Development. The Township, through its officers and manager, shall continue to pursue said financing and grant applications. After the Township has received a final decision from Rural Development, the same shall be reported to this Board for further action.




