“A RESOLUTION TO INCREASE FEES FOR COLLECTION OF CURBSIDE SOLID WASTE SERVICES”

At a regular meeting of the Kochville Township Board of Trustees held at the Kochville Veterans Hall, 3265 Kochville Rd, Saginaw, MI 48604 on the 15th day of October 2018, at 7:00 o'clock p.m., Michigan Time.

WHEREAS, MCL 123.305 (Act 179 of 1947- JOINT GARBAGE AND RUBBISH DISPOSAL), and Kochville Township Ordinance (73-8-R), and Kochville Township Resolutions (04-21 - to Restate the MMWA Articles of Incorporation); (14-024 - Fee Increase For Collection of Curbside Solid Waste Services); (15-25 - Household Solid Waste and Refuse Collection and Disposal Service Special Assessment Roll and Fees); (16-24 - Fee Increase For Collection of Curbside Solid Waste Services); and

WHEREAS, Kochville Resolution No. 16-24 approved the then and current rate of Household Solid Waste and Refuse Collection and Disposal Service Fee of one hundred and fifty dollars (\$150.00) per year as of December 1, 2016; and

WHEREAS, the Kochville Township Board of Trustees has now reviewed and determined that a rate increase is required to continue the Household Solid Waste and Refuse Collection and Disposal Services with the Mid Michigan Waste Authority; and

THEREFORE, BE IT RESOLVED, that the Township Board hereby approves the following Household Solid Waste and Refuse Collection and Disposal Service Fee to be increased to one hundred and eighty nine dollars (\$189.00) per year, and to be added to the next tax billing date and to be in effect as of December 1, 2018.
