Resolution Establishing Hearing on Special Assessment Roll

Kochville Township Davis Road Water Main Installation

At a special meeting of the Township Board of the Township of Kochville, Saginaw County, Michigan, held at the Kochville Township Hall, Kochville Township, Michigan, on the 1st day of November, 2018, at 7:00 p.m., Michigan time.

The Supervisor indicated to the Board that it is now necessary to hold a public hearing to review and approve the special assessment roll for the Kochville Township Davis Road Water Main Installation project. The district boundaries for the special assessment improvement were previously approved by the township board.

The Supervisor then presented to the board a special assessment roll which has been prepared for the Water Main Extension project. Attached to the roll is the Supervisor=s Certificate as required by law.

The following resolution was offered by Trustee Thon and seconded by Supervisor Loiacano:

BE IT RESOLVED BY THE TOWNSHIP BOARD OF THE TOWNSHIP OF KOCHVILLE, SAGINAW COUNTY, MICHIGAN, as follows:

1. The special assessment district description, which is attached to this resolution as Attachment A, is hereby fixed and approved.
2. The special assessment roll in the amount of \$496,063.45, made by the supervisor, has been presented to the township board for the following improvement:

Installation of a water main on Davis Road commencing at a point approximately 775 feet south of the intersection of Davis Road and Pierce Road, and terminating at a point approximately 61 feet South of the intersection of Davis Road and Kochville Road.

The above improvements are located within the previously approved special assessment district, described in Attachment A.

3. The special assessment roll and the special assessment improvement and special assessment district to which the roll applies hereby are designated as the Davis Road Water Main Special Assessment District.
4. The Township Board shall meet at the Kochville Township Veteran's Hall, 3265 Kochville Road, Saginaw, Michigan on the 19th day of November, 2018, at 7:00 p.m., Michigan Time, for the purpose of reviewing the special assessment roll and to hear and consider any objections to them. Notice of the hearing will be given by publishing the same twice prior to said hearing in The Saginaw News, a newspaper circulated in the Township, and mailing it to all persons whose names appear on the special assessment roll as the owners of property in the special assessment district at the addresses in the roll. The first publication and such mailing to shall be at least ten (10) days prior to the time of the hearing.

ATTACHMENT A

Description of Real Property

An area located in Sections 25 and 26, T13N-R4E, Kochville Township, Saginaw County, Michigan lying 300 feet East and 300 feet West of the North/South Section line of Sections 25 and 26 (Davis Road) more particularly described as:

Commencing at the Northwest Corner of Section 25 T13N-R4E, Kochville Township, Saginaw County, Michigan (also the Northeast Corner of Section 26 T13N-R4E); thence along the West Section line of said Section 25, Southerly, approximately 783 feet to the POINT OF BEGINNING, thence Easterly, approximately 300 feet; thence parallel with the West Section line, Southerly approximately 1835 feet to the North/South $\frac{1}{4}$ line of Section 25 and Liberty Road; thence continuing parallel with the West Section line, Southerly, approximately 2,625 feet to the South line of Section 25 and Kochville Road; thence along the South line of Section 25, Westerly, approximately 300 feet to the Southwest Corner of Section 25, thence along the South line of Section 26, Westerly 300 feet, thence parallel with the East line of Section 26, Northerly, 2,626 feet to the North/South $\frac{1}{4}$ line of Section 26 and Liberty Road, thence continuing parallel with the East line of Section 26, Northerly, approximately 1,833 feet, thence Easterly, 300 feet back to the POINT OF BEGINNING
