RESOLUTION NO. 19-04

A RESOLUTION TO APPROVE THE ADOPTION OF THE FIVE-YEAR PARKS AND RECREATION PLAN RECOMMENDED BY THE PARKS AND RECREATION COMMITTEE OF KOCHVILLE TOWNSHIP.

WHEREAS, the Kochville Township Board of Trustees has undertaken a planning process to determine the recreation needs and desires of its residents during a five-year period covering the years 2018 through 2023, and

WHEREAS, the combined area of Kochville Township constitutes the planning area, and

WHEREAS, the Township Board of Trustees began the process of developing a Parks and Recreation Plan in accordance with the most recent guidelines developed by the Michigan Department of Natural Resources and made available to local communities, and

WHEREAS, residents of Kochville Township were provided with a well-advertised opportunity during the development of the draft plan to express opinions, ask questions, and discuss all aspects of the recreation plan, and

WHEREAS, the public was given a well-advertised opportunity and reasonable accommodations to review the draft plan for a period of at least 30 days, and

WHEREAS, a final public comment session was held by the Board of Trustees on December 17, 2018 at Kochville Veterans Hall to provide an opportunity for all residents of the planning area to express opinions, ask questions, and discuss all aspects of the Parks and Recreation Plan, and

WHEREAS, the Board of Trustees has developed the plan as a guideline for improving recreation for Kochville Township, and

NOW, THEREFORE, BE IT RESOLVED, that the Kochville Board approved the Five-Year Parks and Recreation Plan for the period of between 2018 and 2023 on December 17, 2018 at a regular board of trustees meeting, developed by the Parks and Recreation Committee.
