At a regular meeting of the Kochville Township Board of Trustees held at the Kochville Veterans Hall, 3265 Kochville Rd, Saginaw, MI 48604 on the 18th day of May 2020, at 7:00 o'clock p.m., Michigan Time.

WHEREAS, the Kochville Township Board of Trustees ("Township Board") desires to retain the services of an additional assessor, Anissa Zaucha, pursuant to the terms and provisions of the Assessor Agreement to which this Resolution is attached.

WHEREAS, the Township is authorized by statute, specifically MCL 41.61, to appoint additional assessors.

WHEREAS, all additional assessors shall remain subordinate to the Township Supervisor, who remains the chief assessor for the Township.

WHEREAS, the Township Board has reviewed the proposed Assessor Agreement to which this Resolution is attached, and the Township Board is in agreement with the terms and provisions outlined therein.

WHEREAS, the Township Board desires to provide the Township Supervisor and the Township Clerk with the authority to execute the Assessor Agreement to which this Resolution is attached on behalf of the Township.

NOW THEREFORE IT IS HEREBY RESOLVED AS FOLLOWS:

1. The Kochville Township Board of Trustees hereby has determined to engage the services of Anissa Zaucha as an additional assessor for Kochville Township pursuant to the terms of the Assessor Agreement to which this Resolution is attached.

2. The Kochville Township Supervisor and Township Clerk are hereby authorized and empowered to execute the Assessor Agreement to which this Resolution is attached on behalf of Kochville Township.

3. All resolutions in conflict herewith are hereby repealed; and

4. This resolution is effective immediately upon adoption and shall remain in full force and effect until repealed by majority vote of the full five-member Township Board of Kochville Township.


