RESOLUTION ADOPTING FIRST-AMENDED KOCHVILLE TOWNSHIP COVID-
19 PREPAREDNESS AND RESPONSE PLAN

WHEREAS, Governor Gretchen Whitmer has issued Executive Order Nos. 2020-77 and 2020-97, which require, in part, all governmental agencies to develop and adopt a COVID-19 Preparedness and Response Plan.

WHEREAS, the Kochville Township Board of Trustees desires to slow and stop the spread of COVID-19 and to save lives, minimize and mitigate damage, enhance the efficiency of efficacy of Township governmental operations, enhance emergency response operations and enhance and protect the lives of the Township's employees, citizens, residents and property owners.

WHEREAS, the Kochville Township Board of Trustees has determined that the adoption of the Kochville Township COVID-19 First-Amended Preparedness and Response Plan will serve to effectuate the goal and desire described in the preceding paragraph.

NOW, THEREFORE, BE IT RESOLVED:

1. The Kochville Township Board of Trustees hereby fully adopts the Kochville Township COVID-19 First-Amended Preparedness and Response Plan along with Exhibits A-D attached thereto.

2. Said Kochville Township COVID-19 First-Amended Preparedness and Response Plan is subject to change at any time pursuant to the discretion of the Township Board. Said Plan shall remain in effect until further notice.

3. Consistent with the requirements of EO Nos. 2020-77 and 2020-97, and with the text of the Plan itself, said Plan shall be available for review, inspection and copying on the Kochville Township website and at the Kochville Township Governmental Offices.

4. All resolutions or parts of resolutions insofar as they conflict with the provisions hereof are rescinded to the extent of such conflict.
