RESOLUTION NO. 20-16

**A RESOLUTION TO SUSPEND THE PENALTIES FOR BUSINESS LICENSING FOR
THE CALANDAR YEAR OF 2020**

WHEREAS, Public Act 230 of 1972, specifically 125.1522 Fees; provides that a municipality shall establish reasonable fees to be charged by the governmental subdivision for acts and services performed by the enforcing agency; *and*

WHEREAS, Kochville Township, Saginaw County, Michigan (“Township”) desires to revise the fee schedules for business licensing, as it pertains to increased late fees; *and*

WHEREAS, the proposed change is required due to the *Pandemic* requiring business’s to remain closed under the Governor’s Executive Order., and that the Kochville Township Board of Trustees may adjust any fees, add to, and/or delete from the Schedule of Fees and Charges which is subject to change annually or at the discretion of the Township Board; *and*

WHEREAS, such resolution shall remain in effect until April 1, 2021, and is retroactive to April 1, 2020; *and*

WHEREAS, on June 1, 2020, the Kochville Township Board of Trustees received and reviewed the proposed revision to the Business Licensing requirement; *and*

NOW THEREFORE BE IT RESOLVED THAT, that the Township Board hereby adopts by resolution the revocation of the increase of business license fees from April 1, 2020 to April 1, 2021. Any fees already paid in excess of the normal license fee shall be refunded as applicable. The Penalty for failure to obtain a business license remains in effect. This resolution has no effect on any other fees so existing.

The foregoing resolution was offered by board member Supervisor Loiacano and seconded by board member Trustee Thon.


