RESOLUTION ADOPTING KOCHVILLE TOWNSHIP COVID-19 RE-OPENING OF  
OPERATIONS PLAN

WHEREAS, Governor Gretchen Whitmer has issued Executive Order Nos. 2020-91, 2020-96 and 2020-97, which require, in part, all governmental agencies to develop and adopt a COVID-19 Prevention and Mitigation Plan regarding the Re-Opening of Operations.

WHEREAS, the Kochville Township Board of Trustees desires to slow and stop the spread of COVID-19 and to save lives, minimize and mitigate damage, enhance the efficiency of efficacy of Township governmental operations, enhance emergency response operations and enhance and protect the lives of the Township's employees, citizens, residents and property owners.

WHEREAS, the Kochville Township Board of Trustees has determined that the adoption of the Kochville Township COVID-19 Re-Opening of Operations Plan will serve to effectuate the goal and desire described in the preceding paragraph.

NOW, THEREFORE, BE IT RESOLVED:

1. The Kochville Township Board of Trustees hereby fully adopts the Kochville Township COVID-19 Re-Opening of Operations Plan along with Exhibits A-E attached thereto.
2. Said Kochville Township COVID-19 Re-Opening of Operations Plan is subject to change at any time pursuant to the discretion of the Township Board. Said Plan shall remain in effect until further notice.

3. Consistent with the requirements of the aforesaid Executive Orders and with the text of the Plan itself, said Plan shall be available for review, inspection and copying on the Kochville Township website and at the Kochville Township Governmental Offices.

4. The Kochville Township Board of Trustees hereby also fully adopts the Kochville Township Directive Regarding Importance of Personal Hygiene and directs same to be posted in a conspicuous location at the Kochville Township Governmental Office.

5. All resolutions or parts of resolutions insofar as they conflict with the provisions hereof are rescinded to the extent of such conflict.
