Resolution No. 20-22**

Resolution to Tentatively Declare Intention to Designate Special Assessment District for Fire Protection Pursuant to Public Act 33 of 1951, and to Set Hearing Date.

At a regular meeting of the Kochville Township Board, Saginaw County, Michigan, held on July 20, 2020, at 7:00 o'clock p.m., Michigan time.

PRESENT: Supervisor Loiacano, Clerk Machata, Treasurer Knowlton, Trustee Ferrell and Trustee Thon

ABSENT: None

The Supervisor reported to the Board that Public Act 33 of the Michigan Public Acts of 1951 authorizes the Township to establish a special assessment district for fire department operations and for the purchase and maintenance of equipment.

Kochville Township currently has a special assessment district under Act 33, consisting of the entire township, for fire protection purposes. A renewal special assessment would replace, and not increase, the current special assessment.

The Supervisor reviewed with the Board the proposed boundaries for the proposed special assessment district, which include the entire Township.

The following resolution was offered by Trustee Thon and seconded by Treasurer Knowlton:

BE IT RESOLVED BY THE KOCHVILLE TOWNSHIP BOARD, SAGINAW COUNTY, MICHIGAN as follows:

1. This Board tentatively designates the following lands as the special assessment district for fire department operations and for the purchase and maintenance of equipment:

Each of the real properties located within the boundaries of Kochville Township.

2. The Township Board shall meet in the ~~Township Governmental Center~~ **Kochville Veterans Hall** on the 17th day of August, 2020, at 7:00 o'clock p.m. Michigan time, to hear and consider any objections to the improvements and to the special assessment district. Notice of the hearing shall be given by publishing it once prior to the hearing in the Saginaw News, a newspaper circulated in the Township.
