Resolution Designating Special Assessment District Fire Protection

At a regular meeting of the Kochville Township Board, Saginaw County, Michigan, held at the Kochville Veterans Hall on the 17th day of August, 2020, at 7:00 o'clock p.m. Michigan Time.

PRESENT: Supervisor Loiacano, Clerk Machata, Treasurer Knowlton, Trustee Ferrell

and Trustee Thon

The Township Supervisor announced that this was the time fixed for hearing and considering any objections to the proposed special assessment for fire operations and the purchase and maintenance of equipment, and to the special assessment district as tentatively established for the proposed assessment by the Township Board.

The following resolution was offered by Trustee Thon and seconded by Supervisor Loiacano:

WHEREAS, the Township Board has tentatively determined, pursuant to the provisions of Act No. 33 of the Michigan Public Acts of 1951, as amended, to establish a special assessment district to defray the cost of fire operations and for the purchase of and maintenance of equipment.

WHEREAS, this Board has met on this date for the purpose of hearing and considering any objections to the proposed purpose, and to the special assessment district tentatively established for its payment.

THEREFORE, BE IT RESOLVED BY THE KOCHVILLE TOWNSHIP BOARD,

SAGINAW COUNTY, MICHIGAN, as follows:

1. This Board hereby designates, as the Kochville Township Fire Special Assessment

District, against which the cost of the police and operations and purchase of and maintenance of

equipment are to be assessed:

Each of the real properties located within the boundaries of the

Kochville Township.

2. This Board hereby determines to proceed with the above described special assessment in

order to defray the costs of said services in the amount of \$274,392.00.

3. The Supervisor is directed to make a special assessment roll which assesses an amount

equal to two (2) mills for improved commercial and industrial premises, and one (1) mill for

agricultural, residential, unimproved commercial and industrial and all other premises not otherwise

exempt which are located in the Township of Kochville. The roll shall include the names of the

respective owners of the lands in the district, if known, and the total amount of the special

assessment which shall be made pursuant to the provisions of Public Act No. 33.

4. When the Supervisor has completed the special assessment roll, he shall affix his

certificate to it, as required by law, and report the same to this Board.
