Resolution Confirming Assessment Roll

(Kochville Township Fire Protection Special Assessment District)

At a regular meeting of the Township Board of the Township of Kochville, Saginaw County, Michigan, held at the Kochville Veterans Hall, 3265 Kochville Road, Kochville Township Michigan, on the 21st day of September, 2020 at 7:00 p.m. Michigan Time. The Township Supervisor announced that this was the time fixed for hearing and considering any objections to the Kochville Township Fire Protection Special Assessment Roll made to assess lands and premises in the Township for the cost of providing fire protection equipment and operations and affecting the following described property:

Each of the real properties located within the boundaries of Kochville Township.

No written or oral objections were received except as follows:

There were no written or oral objections.

The Township Supervisor thereupon declared the hearing closed.

The following resolutions were offered by Trustee Thon and seconded by Supervisor Loiacano.

WHEREAS, this Township Board has previously approved the establishment of a special assessment district to provide fire protection equipment and operations, and has also approved the assessing of the cost of the special assessment district to the lands and premises in the special assessment district, described above; and

WHEREAS, this Township Board has met on this date for the purpose of hearing and considering any objections to the special assessment roll for such project.

THEREFORE, BE IT RESOLVED BY THE TOWNSHIP BOARD OF THE TOWNSHIP OF KOCHVILLE, SAGINAW COUNTY, MICHIGAN, as follows:

1. This Township Board hereby approves and adopts the Kochville Township Fire Protection Special Assessment District Roll, together with the Certificate of the Township Supervisor, made to defray the cost of providing fire protection. The special assessment of two (2) mills for improved commercial and industrial premises, and one (1) mill for agricultural, residential, unimproved commercial and industrial and all other premises not otherwise exempt which are located in the Township of Kochville is hereby confirmed.

2. This Township Board hereby determines that the annual assessment shall be collected each year beginning December 2020 and continuing each year thereafter as allowed under MCL 41.801 et seq., or until modified or terminated by this Board, whichever first occurs. The Township Supervisor is hereby directed to spread such assessments annually on the Township's tax rolls.

3. The assessments shall be levied and collected each year in the same manner as the Township taxes. Penalties for late payments shall be the same as the penalties for late tax payments.

4. The special assessment shall be subject to modification, pursuant to MCL 41.801, on an annual basis as determined by the Township Board.


