**RESOLUTION TO ESTABLISH SALARY OF THE OFFICE OF THE**

WHEREAS, the Kochville Township Board of Trustees deems that an adjustment in the salary of the office of supervisor is warranted; and

WHEREAS, the Kochville Township Board of Trustees has determined that the adoption of this Resolution will benefit the health, safety, and welfare of the residents and property owners of Kochville Township.

NOW, THEREFORE, BE IT RESOLVED:

1. That as of January 25, 2021, the salary of the office of the Kochville Township Supervisor shall be:

a. \$20,000.00

2. The instant Resolution/Policy shall be available for review, inspection and copying on the Kochville Township website and at the Kochville Township Governmental Offices.

3. All resolutions or parts of resolutions insofar as they conflict with the provisions hereof are rescinded to the extent of such conflict.


